MOU Negotiation Points

The DCAA has agreed with City Attorney management regarding **job descriptions.** We hope to have a signoff with the City soon. The agreement on job descriptions will reopen the DCAA's reduction in force policy. Again, a reduction in force policy is the means by which the City would layoff deputy city attorneys. We do not expect any layoffs to occur, but it is always good to have a policy in place so that we know what to expect in the event layoffs are necessary.

The City and the DCAA, along with MEA, POA, Local 145 (fire), Teamsters 911 (Lifeguards) and Local 127 (City's blue collar workers) continue to negotiate with the City regarding: (1) long term disability benefits' (2) Healthcare benefits-namely the impacts of the Accordable Care Act on the City; and (3) City Employee Recognition policy. We will keep you up to date on how the negotiations are going.

The City will be conducting a **salary survey** of all of its employees including Deputy City Attorneys. The City did an informal survey two years ago which showed that we are significantly underpaid. We expect the results from the survey sometime at the end of next year.

Our Negotiating Team: President Mark Mercer and Vice President (Mike Hudson), Kathleen McManus (Criminal), and Brant Will (Civil). We need a volunteer from the Civil Division to serve on the negotiating team. If you are interested please see Mark Mercer.

DCAA Member of the Month: Jeff Brooker

Jeff was a Deputy District Attorney for Imperial County for six years. He joined the City of San Diego in January of 2014. Jeff is currently assigned to the Domestic Violence and Sex Crimes Prosecution Team. This month Jeff was in trial on a case involving a Defendant who was violently trying to force his girlfriend into his car by holding her by her neck.

After a three day trial, the jury deliberated for four hours. They voted guilty on all counts: domestic battery and false imprisonment, which is a felony wobbler.

Notable Trial Moment: An elderly witness, who attempted to intervene, testified that the defendant took a "pugilistic stance." When cross examined by the defense, the witness responded, "Son, when a man takes a pugilistic stance in front of you, he ain't there to roller skate."
