Dear Counsel:

I am in receipt of requests by (1) the Deputy City Attorneys Association and AFSCME Local 127 to have their pending motions to consolidate granted with respect to the case of the San Diego City Firefighters, presently scheduled for hearing beginning on July 17, 2012, in our Glendale office, (2) the request of the San Diego Municipal Employees Association (which is in agreement with the proposed consolidation) to have its case heard in the same hearing, and (3) the San Diego City Firefighters' motion to consolidate its case with the case of the San Diego Municipal Employees Association. In light of the Court of Appeal decision lifting the stay order of the Superior Court as to the San Diego Municipal Employees Association case before PERB, it is appropriate remove the Deputy City Attorneys Association and AFSCME Local 127 cases from abeyance and move forward with scheduling of the cases not yet placed on calendar.

If the City opposes the proposed request for consolidation and joint hearing beginning on July 17, please file any opposition papers by June 29, 2012.


